### Iowa EDI Claims Release 3.1 Optional Reporting of 2019 SROI AN for Legacy Claims

#### and Iowa Rate Book Calculation Edits

Date: May 22, 2019

#### Legacy Claims (with Date of Injury less than 7/1/2019): Optional Reporting of 2019 SROI AN (Annual):

The SROI AN reporting timeframe occurs starting in July. This year, the SROI AN reporting, falls during the same time that Iowa is transitioning from Release 2 to Release 3.1. Therefore, for legacy claims with Date of Injury less than 7/1/2019 only, Iowa will allow the Trading Partners to do one of the following options to satisfy the SROI AN reporting requirement for this year 2019:

1. SROI UR (Update Report) only and no SROI AN (Annual) due this year 2019

OR

2. SROI UR (Update Report) followed by a SROI AN (Annual) for this year 2019 if you still would like to send the SROI AN for this year.

The next SROI AN will be due in July 2020 per Iowa's SROI Periodic Event Table.

#### Iowa Rate Book Calculation Edits:
